Once again, I bring you greetings from the Martha Mason Hill Memorial Foundation. It has been a good, but challenging year. With your help, the Foundation continues to support students, teachers, and schools. Our scholarship recipients continue to make us proud. The Foundation has encouraged students to read for pleasure by providing them books of their choice; for we know that the ability to read well is the foundation for

success in all disciplines. Finally, the data shows that investing in quality teachers is the most effective way to provide quality education for all students, so the Foundation has adopted this strategy. On behalf of the Foundation, I thank you for helping to provide the resources that allow us to be a part of the nurturing, supportive community that serves our students.

The Foundation has pledged its support for quality education. We strongly believe that all students can learn if they have access to quality teachers and are in a supportive, safe environment. We also believe and understand that change takes time. The evidence that supports these beliefs is beginning to emerge as schools that were once among the worst performing are moving into the class of "best performing". These schools are in poor neighbors and serve a diverse population. Their common characteristic is that students believe they can learn; teachers believe that the students can learn; parents recognize that learning takes place outside the classroom and that they play a vital role in that process; administrators are held accountable for what the system does or fails to do; and political leaders recognize that resources must be provided.

The current economic climate has shown us that a solid education significantly increases the probability that one will survive the downturn. Does it guarantee a job? It does not, but the data shows that those with solid skills are more flexible, more adaptable and more likely to find a new position when the one they have is eliminated. The Martha Mason Hill Memorial Foundation's goal is to provide all students with a fighting chance. We need your continued help to do so!

2008 was a landmark year on many accounts. The changes on the political landscape energized and gave hope to many that did not believe that their participation could make a difference. We now know differently! But much work remains. The weak economy has pointed out the need to concentrate on the basics and to reassess what is really important for us individually and for us as a nation. We have listened to the comments and read the writings of some that cause us to think carefully about the differences between our rights and our privileges. We must remember that there is no excuse for bad manners! The bottom line is that we must continue to respectfully make our voices heard. It is time for the silent majority to wake up, to speak up, and to let our local, state and national leaders know that the vocal minority does not speak for us. Our namesake, Mrs. Hill, would implore us to each do our part. Addressing the problems that confront our community, our state and our nation is not someone else's job - it is a responsibility we all share. Let's all do our part.

#### A TRIBUTE TO BRENDA FRIEND BRIGGS, ESQ

The Martha Mason Hill Memorial Foundation joins the community in celebrating the life and legacy of Brenda Friend Briggs, a truly unique and amazing person. She had so much to offer, and always strived to do her best. Her contributions to the Foundation, the community and countless individuals were innumerable. Hers was a life of service, a shining example worthy of emulation. She exemplified the ideals of our organization and our namesake.

Preservation of legacy and service to others is significant to the Foundation and was also to Brenda. She sought to not only preserve the contributions of her family's ancestors, but was in the process of gathering the stories of other outstanding African Americans in Chesterfield, many whose stories are yet untold.

When asked by Gwendolyn Davis to become a member of the Board, Brenda consented in spite of her many obligations and commitments. She served as a member of the Board for three years, 2003-2006. During that time, her contributions were many including being a member of the Outreach Committee and Constitution Committee. She sought every opportunity to promote MMHMF and worked diligently to further the Foundation's goals. She attended the meetings and events regularly and supported all of the projects and programs.

It was Brenda's recommendation and subsequent efforts that the Board honored the late Oliver White Hill which had never been done in Chesterfield County. This was another of Brenda's "firsts". She was also responsible for having him attend the Awards Program in 2004, and having Richard "Dickie" King, Jr., Supervisor of Bermuda Magisterial District, present the Chesterfield County Proclamation to Mr. Hill.

In 2005 Brenda invited the Foundation to co-sponsor with the Trustees of First Baptist, Centralia, the AFRICAN AMERICAN RAIL TRAIL; the History of African Americans in Chesterfield County, Virginia. The trip was by train from Ettrick, Virginia to Richmond, Virginia. This was Brenda's creation and another of her "firsts". The first tour was on January 15, 2005 (Martin Luther King Day) and the second was February 12, 2005 (during African American History Month). Participants received packets that contained a wealth of historical literature. Brenda was the narrator for both very successful tours.

The Martha Mason Hill Foundation was blessed to be the beneficiary of Brenda's Christian spirit, her devotion to whatever she undertook, her creativity, and energy. We will always remember the tremendous impact she had on the Foundation and be grateful for how she inspired us to pursue our goals. We thank God for the love she showed, the inspiration she gave and her many other contributions. She will be dearly missed.

#### REFLECTIONS OF BRENDA F. BRIGGS, ESQ.

MAJOR GENERAL BRUCE E. ROBINSON, ESQ.: It was a short thirty two years ago that I met Brenda Friend Briggs in the halls of the T.C. Williams School of Law, University of Richmond. Carrie Willis Johnson received her early education experiences in the Prince Edward School System, Farmville, Virginia, graduating from Robert Russa Moton High School on June 4, 1956 as valedictorian of her class. She continued her studies at Virginia Union University, Richmond, Virginia, graduating with the Degree of Bachelor of Science - The Division of Natural Sciences and Mathematics on June 6, 1960. On May 21, 1972, Virginia State College, now University, conferred upon her the degree of Master of Education in Mathematics Education. She has done further studies at the College of William and Mary, Williamsburg, Virginia; University of Virginia,

Charlottesville, Virginia; John Tyler Community College, Chester, Virginia and Richard Bland College, Petersburg, Virginia.

Mrs. Johnson's teaching experiences began in 1960 with the Nottoway Public School System. Other school systems where she worked include the Spotsylvania Public Schools (John J. Wright), Prince Edward Free Schools, Prince Edward Public Schools, Chesterfield County Public Schools (Matoaca Middle and Matoaca High Schools), Adjunct Professor at Virginia State, and Petersburg Public Schools (Peabody Middle School).

Mrs. Johnson is a member of many community organizations that include The Links, Incorporated, Petersburg Chapter: The Moles, Incorporated, Petersburg Chapter; and The Wives of Beaux Twenty. She is a member of Gillfield Baptist Church where she sings in the Gospel Choir and is a teller.

She is married to Dr. Norris J. Johnson. They were blessed with two children, Brenda Juacita (deceased) and Norris Dwayne; daughter-in-law, Charon and four grandchildren: James Bryant, Juacita, Chenteria and Arianna.

#### **MMHMF OUTREACH PROJECTS**

#### September 2008 - July 2009

For more than ten years, the Martha Mason Hill Memorial Foundation has strived to provide educational opportunities that aid students in reaching their potential. Over the years, the Foundation's Outreach Committee has focused on two elementary schools in Southern Chesterfield County, Ettrick and Harrowgate Elementary Schools. To ensure that every child has basic supplies for learning, each year in September, the Foundation and friends of the Foundation donate several baskets of school supplies to each school.

The Outreach Committee meets three to four times per year to evaluate and plan for outreach activities. School personnel are consulted to find ways to motivate students to be successful in school

In November 2008, the Foundation gave Harrowgate Elementary School a monetary donation to pay field trip fees for students whose families cannot afford them. In addition, the Foundation sponsored a trip to the circus for the pre-K class at Harrowgate. This was a very rewarding experience for these very young students. None of them had ever gone to a circus!

Every February, between forty and fifty college students are sent care packages. This is a very popular and effective program. MMHMF receives numerous thank you notes from students each year. Parents also express their gratitude to the Foundation.

Harrowgate Elementary School celebrated Dr. Seuss's birthday in March of 2009. The Outreach Committee participated by providing approximately 30 Dr. Seuss books for the students.


